CKC AGILITY TITLES

Standard

AG.N. – Agility Novice

AG.I. – Agility Intermediate

AG.X. – Agility Excellent

AG.M.X. – Agility Master Excellent

AG.M.CH. – may be used for dogs which achieve the AGMX and AGMXJ titles.

CKC permits the use of a number indicating a Masters level title earned a second, third or fourth time e.g. AG.M.X.2. and so on.

Jumpers with Weaves

AG.N.J. – Agility Novice Jumper

AG.I.J. – Agility Intermediate Jumper

AG.X.J. – Agility Excellent Jumper

AG.M.X.J. – Agility Master Excellent Jumper

Selected and Veteran Titles

Titles for Selected include an "S" at the end of the title e.g. AG.N.S. Titles for Veterans include a "V" at the end of the title.

CLASSES

Agility Novice A (Standard or Jumpers with Weaves): For persons and dogs that have never acquired an agility title in any country or with any organization.

Agility Novice B (Standard or Jumpers with Weaves): For agility instructors and judges, and for dogs that have acquired the Agility Novice title, but have not earned a qualifying score in Agility Intermediate, and, for persons who have previously exhibited a dog to an agility title in any agility organization.

Novice Jumpers with Weaves will have one set of 6 weave poles used once.

Agility Intermediate (Standard or Jumpers with Weaves): Open to dogs that have acquired the Agility Novice title, and to those dogs which have acquired the Agility Intermediate title but have not yet acquired a qualifying score towards the Agility Excellent title.

Agility Excellent A (Standard or Jumpers with Weaves): For dogs that have acquired the Agility Intermediate title, but have not yet earned the Agility Excellent title.

Agility Excellent B (Standard or Jumpers with Weaves): For dogs that have acquired the Agility Excellent title or the Agility Master Excellent title.

Divisions – Regular, Selected, Veterans

Selected Classes

Any dog eligible to participate in a CKC agility trial may enter the Selected Class, but cannot be entered in the Selected Class and the Regular Class at the same trial or set of trials. Dogs entering the Selected Class must progress through the various levels beginning with the Novice level. In the Selected Classes dogs jump one height lower than their regular jump height, and the Standard Course Time is increased by 10%. In Novice Selected and Novice Veterans the classes are not divided into A and B.

Veteran Classes

Dogs 7 years or older may be entered into the Veterans division at one OR two heights lower than their Regular jump height. Dogs entered in Veterans may NOT move back into Regular or Selected. The dog will retain titles and/or Qualifying scores towards titles accumulated, and will have the same 10% additional time as Selected dogs.

REGULAR JUMP HEIGHTS (one height lower than Regular for Selected, one or two heights lower for Veterans)

4 in. (Selected and Veterans only)

8 in for dogs 10" and under

12 in for dogs over 10" up to and including 14"

16 in for dogs over 14" up to and including 18"

20 in for dogs over 18" up to and including 22"

24 in for dogs over 22"

Owners are responsible for entering the correct height division. Dogs that run in a height division lower than their correct division will be eliminated. Judges may require any dog to be measured.

ENTRIES

1. All dogs must be individually registered with the CKC or eligible for CKC registration.
2. The entry form must be completed in every respect and exhibitors must abide by any errors made in entering their dogs regardless of how, or by whom the entry was made.
3. No entry will be accepted unless accompanied by the entry fee. Incomplete entries will be returned.

- The tendering of a dishonoured (NSF) cheque in payment of entry fees shall be considered non-payment of entry fees and is an offence subject to disciplinary action and cancellation of awards.

Please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates, discounted cheques will not be accepted. Personal cheques will be accepted; however, they are to be payable in Canadian funds. If you send a cheque in US funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please do not mark cheques "Payable in Canadian Funds" or "At Par". They will not be cleared by the banks. To simplify the process, we urge that you purchase bank drafts or money orders payable in Canadian funds. Your understanding and cooperation is appreciated. Thank You.

NOTICE TO EXHIBITORS

- The precinct of the trials shall be the ring enclosure and 10 ft. surrounding.
- Only dogs entered for competition will be permitted in the precinct of the trials.
- No provisions have been made for rain or sun. Bring your chair and protection from the weather for yourself and your dog.
- Please do not litter. Use the designated area for your dog, and then clean up.
- Dogs must be under control at all times and kept on a leash except in the warm up area and on the course.
- No food or other device will be allowed on the course. The dog may wear a buckle collar, a quick release collar or no collar on the course.
- Competitors participate at this event at their own risk. The release form must be signed.
- All obstacles will conform to CKC specifications.
- Club Agilité Canin de St-Lazare reserves the right to refuse entries, subject to CKC rules.
- Electronic timing will be used.

MOVE-UPS

A dog earning a title after the closing date may advance to a higher level providing the Trial Secretary is notified one week prior to the trial. Move-ups will be permitted between the Saturday and Sunday trials. The move-up form must be completed and handed to the secretary on Saturday by the end of the second trial.

ALTERNATE LIST, REFUNDS

1. No entries may be accepted, altered, cancelled or substituted after the closing date.
2. In the event that the entry limit is reached before the official closing date, an Alternate List will be compiled in the order received. Alternate dogs will be allowed to run in the place of any absent dogs. Alternate dogs which are not able to run shall have the entry fees refunded.
3. There shall be no refunds in the event that the dog is absent on the day of the trial, or if the dog/handler is dismissed from competition, regardless of the reason for such dismissal, or in the event of inclement weather, other than as provided for below.
4. Bitches in season are not permitted to compete. When a bitch comes in season after the entry has been submitted, a refund will be made on submission of a veterinary certificate prior to the day of the trial, certifying that the bitch was in season within the 10 day period preceding the trial.
5. When a dog has become injured after the closing date, a refund will be made on submission of a veterinary certificate prior to the day of the trial, certifying that the dog has sustained injury

AWARDS

In all classes: Rosettes/ribbons from 1st to 4th place for dogs with qualifying scores in each division and height category. All dogs with a qualifying score will be awarded a flat qualifying ribbon. A Club Agilité Canin de St-Lazare special rosette will be awarded for a CKC title achieved at these trials.

CKC AGILITY RULES AND REGULATIONS - CONDUCT

Section 18.7 It shall be the duty and obligation of the trial giving club to see that a judge, club official, volunteer, or any participant at an event held under these rules, is not subject to indignities of any kind. The Agility Trial Chair shall promptly report to the CKC any infringement of this regulation, and the Discipline Committee shall have the authority to take such action as it deems fit on receipt of a report that this has occurred.

EVENT REGISTRATION NUMBER (ERN)

Dogs that are foreign-born and owned who enter Canada for the sole purpose of competing in CKC events do not require a CKC registration number, but do require an Event Registration Number. (ERN) This must be applied for within 30 days of entering a CKC event. From Montreal - Hwy 40 West to Hwy 540. Take Exit 3 (first exit). Left on Rte 340 for 4km. Right at traffic lights onto Ste-Angélique for 3 km to St-Lazare Airport on the left.

From Ottawa - Hwy 40 East, Exit 26, Right on Bédard/Daoust for 3km to Ste-Angélique. Turn left on Ste-Angélique for 1 km approx. to St-Lazare Airport on the right.

From Toronto - Hwy 20 East, Exit 17 (St. Clet, 201 north) to chemin Ste-Angélique. (13.5 km) Right on Ste-Angélique for 8 km approx. to St-Lazare Airport on the right

Alternative route - Hwy 20 East to Junction 29, Hwy. 540 to Exit 3. Left on Rte. 340 for 4km. Right at traffic lights onto Ste-Angélique for 3 km to St-Lazare Airport on the left.
